The departmental officers in the feeder grade in CDSCO who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment on deputation shall be not exceeding 56 (fifty six) years as on the closing date of receipt of applications.

The officer selected on deputation will have the option to draw his parent cadre pay plus deputation (duty) allowance or the pay scale/grade pay of the deputation post in accordance with the Department of Personnel & Trg's O.M. No. 6/8/2009-Estt. (Pay.II) dated 17.06.2010 as amended from time to time.

For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with common grade pay or pay scale where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

The eligible and interested persons may apply through proper channel on the pro forma given below (in duplicate). The applications should reach the undersigned within 45 days of publication of this advertisement in the Employment News. While forwarding the applications it shall be ensured that the particulars of the candidate/s are duly verified from their service records, that they actually fulfill the eligibility requirements and no Vigilance case/disciplinary proceedings are pending /contemplated against the candidate concerned.
