
Subject:- Filling up the post of Drugs Inspector (Medical Devices) in CDSCO, New Delhi on deputation basis.

Services of a suitable officer for the post of Drugs Inspector/Medical Devices in CDSCO, Directorate General of Health Service are required as per details given in the Annexure-I. The pay of the Officer selected will be regulated in accordance with the revised pay structure level 8 in pay Metrix. The period of deputation will not ordinarily exceed 3 years.

2. Interested Officers who are eligible to apply for the post, should apply giving the detailed information as per annexure-II. Officers who volunteer for the post will not be allowed to withdraw their names later.

3. It is requested that names of suitable officers who are eligible and can be spared immediately may be sent to the undersigned by the 05.03.2018 at the latest. The ACRs/APARs for the last 05 years of the applicants may also kindly be sent along with their applications to the undersigned.

Eligibility Conditions:

1. On Deputation(ISTC):

A)

- i) Holding analogous post on regular basis in the parent cadre/department;;
- ii) With two years' service in the grade rendered after appointment thereto on a regular basis in the level-7 in the pay matrix or equivalent in the parent cadre/department; or
- iii) With six years' service in the grade rendered after appointment thereto on a regular basis in level-6 in the pay matrix or equivalent in the parent cadre/department; and

B) Possessing educational qualifications and experience prescribed for direct recruits under column 6.

Note 1: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation (ISTC). Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing dated of receipt or applications.
